PRE-K TUITION

(Pre-K tuition is not discountable, either by multi-child discount or by financial assistance.)

FEES (Non-refundable)

Enrollment Fee (per Family)	\$200 <u>per family</u> (Billed immediately at the end of the FACTS enrollment process) \$100 discount is applied if enrollment is completed on FACTS by 11:59 pm on March 1, 2024. Absolutely no extensions or exceptions will be made.
FACTS Mgmt. Annual Enrollment Fee	\$50 <u>per family</u> (billed in June of 2024; this is a non-refundable fee; waived if “Pay in full” payment plan is chosen and payment is made, in full, by August 15, 2024)
Curriculum Resource Fee	Pre-K - \$125 <u>per student</u> (billed in July of 2024; this is a non-refundable fee) K-8 th grade - \$250 <u>per student</u> (billed in July of 2024; this is a non-refundable fee) 8th grade graduation fee (TBD based on

FUNDRAISING FEE - Raffle tickets (Non-refundable)

Families with only one half-day student	\$200 fee = 20 tickets at \$10 each (billed in July of 2024; this is non-refundable)
Families with only two half-day students	\$400 fee = 40 tickets at \$10 each (billed in July of 2024; this is non-refundable)
Families with at least one full-day student	\$400 fee = 40 tickets at \$10 each (billed in July of 2024; this is non-refundable)

NOTE: Raffle tickets will be available to parents in late August, once the July fee payment has been made via FACTS. and we are back in school parents can pick up their raffle tickets from the school office and should sell them, keep the money, and turn in the sold tickets, completed, prior to the first monthly money raffle in September of 2024. This can be a 100% pass through cost if you sell all your tickets.

MANDATORY SERVICE HOURS (performed between April 31, 2024 - May 1, 2025)

Families with only one half-day student	10 hours (5 of which must be helping on a major fundraiser or admissions event– Haunted House, Wolf Run, CSW Open House, etc.)
Families with only two half-day students	20 hours (5 of which must be helping on a major fundraiser or admissions event– Haunted House, Wolf Run, CSW Open House, etc.)
Families with at least one full-day student	20 hours (5 of which must be helping on a major fundraiser or admissions event– Haunted House, Wolf Run, CSW Open House, etc.)

NOTE: Service hours short of the mandatory number will be billed at \$15 per hour on a May 2025 FACTS bill.

NOTE: Hours completed AFTER May 1 will apply toward the 2025-2026 school year.

NOTE: The FACTS Grant and Aid Application will be open between January 27 and March 1. Awards will be made in May.
